## East 40 Classroom Update

Budget - \$1 million from state; NCC – additional \$500,000. Cost came in from architects at \$1.9 million. Options: postponing project, pare down, fund raising? Zoning is an issue; the East 40 parcel is zoned differently than the rest of the campus, and education is not a permitted use. East 40 parcel may need to be rezoned; this will be good, to include existing structures.
